**Background:** Advertisements soliciting sealed bids for the Country Village Advanced Clearing, Project No. OVPZ&D 22-06 were placed in local newspapers and the Town's website. Bid proposals were accepted by the Town Manager at the Municipal Building located at 201 Central Avenue on Thursday, July 1, 2021.

This work involves furnishing all labor, materials, transportation, tools, supplies and equipment necessary to remove trees along a large drainage ditch adjacent to South Horseshoe Drive in the Country Village Community in advance of a drainage improvement project scheduled for construction in the Fall of 2021.


One sealed bid was received and opened.

A complete review and summary of the bids was performed by Mike Baiocco, Project Manager, TKG, Inc. and is attached for your review.

**Funding:** Funding is available for these repairs in the FY 2022 Capital Improvement Budget under the Project Number 19-0205P totaling \$301,963.00.

**Recommendation:** It is therefore recommended that the Mayor & Council authorize the Town Manager to enter into a contract with Sussex Tree, Inc. for the total bid amount of \$10,800.00.

Dear Mr. Cimino,

One (1) bid was received for the above-referenced project on July 1, 2021. The bid was submitted by Sussex Tree, Inc., with a lump sum bid of \$10, 800.00.

As you know this clearing work was pulled from the pending Country Village Drainage project with the expectation that a cost savings could be realized by the Town in doing so. These anticipated savings included the prime contractor mark-up of subcontractor's price, the prompt payment for work completed, among other considerations.

The engineers estimate ranged from \$20,000.00 to \$30,000.00 for this work.

I believe the cost savings has been realized. With that in mind, I recommend that the project be awarded to Sussex Tree, Inc., 20350 Nelson Drive, Bridgeville DE, 19933 for the lump sum bid of \$10,800.00.
