- Officer Tara Mazza was recognized for her lifesaving efforts on April 4th during the annual Phoenix Award ceremony at Delaware Technical & Community College in Georgetown.
- Chief McLaughlin attended the monthly meeting of the Delaware Police Chiefs Association on April 8.
- On April 11, the Delaware Police Accreditation Commission (DPAC) conducted an on-site inspection of the police department. The assessment included a final review of the department's policies and procedures as well as a facility and equipment inspection. The

assessment team found OVPD in compliance with all accreditation mandates. On April 29th, the DPAC voted unanimously to award re-accreditation to the OVPD for a period of three years.

- On April 13th, Chief McLaughlin delivered food and visited dispatchers at the Sussex County Emergency Operations Center in celebration of Telecommunicators Appreciation Week.
- During the week of April 14th, OVPD hosted the Advanced Law Enforcement Rapid Response (ALERRT) – Active Attack Integrated Response Train-the Trainer Course. The course is a performance level course designed to improve integration between police, fire, dispatch and EMS in active attack / shooter events.
- OVPD SRO Sergeant Rhys Bradshaw teamed up with DelDOT to host a Bike Safety Rodeo on April 16 at Lord Baltimore Elementary School.
- Chief McLaughlin attended the Law Enforcement Officers Memorial Committee Meeting on April 22.
- OVPD and FOP Lodge 16 held a fundraising golf tournament at Bear Trap on April 14th. The event raised over \$15,000 to support the Cops & Goblins event scheduled for Saturday, October 25th.
- On April 28th, OVPD hosted a meeting of the regional Child Abduction Response Team.
- On April 28th, Chief McLaughlin held a shift supervisors meeting.
- Police Appreciation Day May 15th. The Police Memorial Flag will be raised at 0900 at OVPD. Coffee and refreshments will follow.
