1 ORDINANCE NO. _____ 2 3 4 5 6 7 AN ORDINANCE AMENDING THE TOWN OF OCEAN VIEW CODE RELATING TO LICENSES **AS SET OUT IN CHAPTER 93** WHEREAS, pursuant to Section 2.313 of the Ocean View Charter, the Town 8 Council of the Town of Ocean View has all powers which, under the Constitution of the 9 State, it would be competent for the General Assembly to grant by specific enumeration, and which are not denied by statute; and 10 11 12 WHEREAS, the Town Council has the power to adopt ordinances for the protection 13 and promotion of the health, safety, and welfare of the residents of the Town; and 14 15 WHEREAS, the Town Council deems it appropriate, necessary and proper for the health, safety and welfare of the residents of the Town of Ocean View to adopt an ordinance 16 pertaining to the cultivation, manufacturing, testing and retail of marijuana within the Town 17 18 of Ocean View; and 19 WHEREAS, the Delaware Marijuana Control Act specifically provides that a 20 21 municipality may prohibit the operation of marijuana cultivation facilities, marijuana product manufacturing facilities, marijuana testing facilities, or retail marijuana stores 22 23 through the enactment of ordinance or through an initiated or referred measure; and 24 25 WHEREAS, the Town Council desires to amend certain sections of the Code of the Town of Ocean View (the "Code") related to licenses as set out in Chapter 93, Licenses, to 26 27 prohibit the issuance of licenses for certain marijuana related business. 28 29 NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE TOWN 30 COUNCIL OF THE TOWN OF OCEAN VIEW: 31 Amend § 93-2 of Chapter 93, Licenses, of the Code by adding thereto 32 Section 1. 33 those matters underlined as follows: 34 35 36 E. No license shall be issued by the Town of Ocean View for the operation of a 37 marijuana cultivation facility, a marijuana product manufacturing facility, a marijuana testing facility, a retail marijuana store, each as defined in Title 4, Section 38 1302 of the Delaware Code, or a marijuana smoking lounge within the municipal 39 40 limits of the Town of Ocean View. 41 42 This ordinance is subject to the Pending Ordinance Doctrine. Upon Section 2. 43 its introduction at the July 11, 2023 meeting of the Town Council, the Town shall thereafter 44 reject any applications inconsistent with the amendments to Chapter 93 provided in the ordinance until such time as the Mayor and Town Council take action on the ordinance to 45 either approve or reject, with our without amendments. 46

Section 3. If any provision of this ordinance shall be deemed or held to be invalid or unenforceable for any reason whatsoever, then such invalidity or unenforceability shall not affect any other provision of this ordinance which may be given effect without such valid or unenforceable provision, and to this end, the provisions of this ordinance are hereby declared to be severable.

Section 4. This ordinance shall become effective upon its adoption by a majority of all members elected to the Town Council.

Synopsis

The purpose of this ordinance is to prohibit the issuance of licenses to operate various marijuana related businesses in the Town of Ocean View. The Delaware Marijuana Control Act specifically provides that a Municipality may prohibit marijuana cultivations facilities, marijuana product manufacturing facilities, marijuana testing facilities, or retail marijuana stores through the enactment of an ordinance or through an initiated or referred measure.
